**Subject:-Revision in SWAYAM Schedule in the wake of COVID-19**

Dear Sir/Madam,

This is in continuation of earlier UGC letter of even no. F.NO 1-8/2017 (SWAYAM Board) dated 19.05.2020, wherein UGC has informed the schedule of 82 UG and 42 PG SWAYAM Courses (Non-Technology) to all the Vice-Chancellors of the Universities and Principals of all College and requested them to accept these MOOCs for credit Transfer as per the UGC(Credit Framework for online courses through SWAYAM) Regulations 2016 and 1<sup>st</sup> Amendment on 8<sup>th</sup> May, 2017.

In this regard, I would like to inform that in the wake of COVID-19 and as requested by the National Coordinators of SWAYAM, in the Task Force on Integrated Online Education meeting of MHRD, the competent Authority has approved the following:

- 1. The end term proctored examination for the January 2020 semester SWAYAM courses which were postponed, would now be held on 15<sup>th</sup> and 16<sup>th</sup> September 2020. This would be organized by NTA.**
- 2. The ongoing and pending activities/schedule for the July 2020 semester SWAYAM courses would be extended by 45 days. The revised time schedule for the activities is as follows:**
