MINUTES OF THE 503rd MEETING OF THE UNIVERSITY GRANTS COMMISSION HELD ON 22nd September, 2014.

The 503rd Meeting of the Commission was held on 22nd September, 2014 in which the following were present:

Prof. Ved Prakash, Chairman, UGC welcomed the Members. He apprised them of the following developments:

- 1. He informed that the MHRD vide its Order dated 30th July, 2014 constituted a 4-Member UGC Review Committee under the Chairmanship of Dr. Hari Gautam, Former Chairman of UGC. He further informed that the Committee had its meeting on 5th and 6th September, 2014 wherein Secretary UGC made a presentation on the role and functions and major initiatives undertaken by the UGC in the recent past.
- 2. He informed that extension of deputation of both Shri Upamanyu Basu, Financial Adviser and Shri Vikram Sahay, Director (Admn.) did not come through and hence they had to be repatriated to their parent cadres.

The Chairman also informed the Commission that since both the FA and Director (Admn.) are key posts in the day-to-day functioning of the UGC Office, the Commission may kindly accord permission to fill-up both the positions. The Commission took note of the situation and urged the Chairman to fill in the posts at the earliest.

- 3. The Chairman, apprised the members of the Retreat of the Vice-Chancellors of Central Universities organized at Chandigarh on 12-13 September, 2014 which was chaired by the Hon'ble HRM. He briefed the Commission of the Agenda discussed at the Retreat and its final outcome.
- 4. He also informed that a Consultative Meeting of Vice—Chancellors of Central and State Universities and State Education Secretaries on 'Reforms in Teacher Education' was held on 15th September, 2014, in which the morning session was chaired by the Hon'ble HRM.
