These itineraries should not only focus on the selection of Yuva Sangam delegates but also facilitate meaningful interactions with various stakeholders, including industrial bodies, associations, local dignitaries, entrepreneurs, artists, and NGOs. The goal is to enrich the overall experience and learnings of the Yuva Sangam delegation.

To facilitate seamless coordination and implementation, the Department of Higher Education, Ministry of Education, has formulated a comprehensive Standard Operating Procedure (SOP), Checklist, and Best Practices Document for Yuva Sangam IV.
