Subject: Publicity for Creating Awareness of the three New Criminal Laws

आदरणीय महोदया/महोदय,

This is in continuation of UGC letter No. 2-5/2024(CPP-II) dated 16.02.2024. As you are aware, the Bharatiya Nyaya Sanhita, 2023, Bharatiya Nagarik Suraksha Sanhita, 2023, and Bharatiya Sakshya Adhinyam, 2023, will replace the British era colonial laws, namely, the Indian Penal Code, the Code of Criminal Procedure and the Indian Evidence Act respectively. The Central Government has appointed the 1st day of July 2024 as the date on which the provisions of these new Criminal Laws shall come into force. A copy of the Gazette Notification dated 24th February 2024 in this regard is attached.

The Higher Education Institutions are requested to organize seminars, workshops, and lecture series on various provisions of three new Criminal Laws for dissemination among the students, staff, and wider community, and a repeat of activities during the next fortnight may also be taken by way of reinforcement and as a build-up of the commencement of new Criminal Laws on 01st July 2024.

It is further requested that coinciding with the commencement of the new Criminal Laws on 1st July 2024, HEIs may organize a day-long activity including focused group discussions, workshops, seminars, Q&A sessions, quizzes on various provisions of new Criminal Laws highlighting the major transformation intended to achieve the ends of Justice or Nyaya and ensure wider participation of students and faculties and other staff.
