(Deferred item nos. 2.09 & 2.04 of 524<sup>th</sup>& 525<sup>th</sup> Meetings of the Commission dated 24.08.2017 & 4.09.2017 respectively).

Considered and Approved, with the following additional changes in the Draft Regulations:

(i) Eligibility clause 6.4 of the Regulations, may be replaced as follows:

The Colleges must be accredited by either NAAC with minimum 'A' grade or by NBA for atleast three programmes with a minimum score of 675 individually. However, if the number of programme(s) being run by the Institution is less than three, then each of the programmes should secure 675 or more marks.

(ii) Extension clause 10.3 of the Regulations, may be replaced as follows:

if the College under consideration has obtained a score of 3.5 and above on a 4 point scale from NAAC or a minimum of three programmes have been accredited by NBA with a minimum score of 750 individually, the College shall be granted extension of autonomous status for further ten years without the visit of the UGC Expert Committee, after placing the report of the NAAC/NBA team and the reports of the External Peer Team of IQAC of the College before the Standing Committee constituted by the UGC.

- (iii) Under clause 10.4 on page 302, in the second line it be read <u>clause 8.1</u> and not clause 9.1.
- (iv) Under clause 13.2 on page 303, in the third line Sexual Harassment Committee be replaced with *Internal Complaints*Committee.
- (v) Term: The Governing Body shall be reconstituted every <u>three</u>

  <u>years</u> except in the case of UGC nominee who shall have term
  of five years. (Refer Page 304).
- (vi) Meetings: Meetings of the Governing Body shall be held at least <u>twice a year</u> (Refer Page 304).
- (vii) Under clause 13.4 ACADEMIC COUNCIL (page 305), the term of the nominated members shall be <u>three years</u>.
- (viii) Under clause 13.5 BOARD OF STUDIES (page 306), the term of the nominated members shall be <u>three years</u>.
- (ix) Under clause 13.6 FINANCE COMMITTE (page 307), the term of the Finance Committee shall be <u>three years</u>.
- (x) Under clause 16.1 (page 308), the last sentence, "All UGC directives shall be strictly followed" be deleted.
- (xi) A new Clause 18 to be added as below:
  "All UGC directives shall be strictly followed, failing which UGC may take appropriate actions, as it deems fit, against the defaulting Autonomous College".

(xii) Removal of Difficulties clause to be added as below:

University Grants Commission reserves the right to remove difficulty/difficulties in the course of implementation of these Regulations in consultation with the Government of

India/Ministry of Human Resource Development.

The existing Guidelines for Autonomous Colleges shall be treated as deemed amended to the extent of the provisions of the approved draft UGC (Autonomous Colleges) Regulations, 2017. Till the proposed Regulations are duly notified in the Gazette, the scheme for Autonomous Colleges will continue to be implemented with the amended Guidelines.

# SECTION-4 (SPECIAL PROGRAMMES, QUALITY PROGRAMMES ETC)

4.01 To consider and approve University Grants Commission (Categorization of Universities (Only) for Grant of Graded Autonomy) Regulations – 2017. (Deferred item nos. 4.05 & 4.05 of 524<sup>th</sup> & 525<sup>th</sup> Meetings of the Commission dated 24.08.2017 & 4.09.2017 respectively).

Considered and Approved, with the following modifications:

## (i) Clause 4.7 to be replaced as:

Universities, subject to the Rules, Regulations and Guidelines of Government of India, may hire, without approval of the Commission, foreign faculty having taught at any institution appearing in top five hundred of any of the world renowned ranking frameworks, such as the Times Higher Education World University Rankings or the QS Rankings, upto twenty percent over and above of their total sanctioned faculty strength. Universities will have the freedom to hire foreign faculty on "tenure/contract" basis as per the terms and conditions approved by their Governing Council/Statutory bodies.

#### (ii) Clause 4.8 to be replaced as:

Universities shall be free to admit foreign students on merit, subject to a maximum of twenty percent, over and above of the strength of their approved domestic students. Universities would be free to fix and charge fees from foreign students without any restriction.

### (iii) Clause 5.5 to be replaced as:

Universities, subject to the Rules, Regulations and Guidelines of the Government of India, may hire, without approval of the Commission, foreign faculty having taught at any institution appearing in top five hundred of any of the world renowned ranking frameworks, such as the Times Higher Education World University Rankings or the QS Rankings, upto twenty percent over and above of their total sanctioned faculty strength. Universities will have the freedom to hire foreign faculty on "tenure/contract" basis as per the terms and conditions approved by their Governing Council/Statutory bodies.

### (iv) Clause 5.7 to be replaced as:

Universities shall be free to admit foreign students on merit subject to a maximum of twenty percent, over and above of the strength of their approved domestic students. Universities would be free to fix and charge fees from foreign students without any restriction.

- (v) Clause 5.4 is to be deleted.
- (vi) Clause 9 (REMOVAL OF DIFFICULTIES) to be added as below:

UGC reserves the right to remove difficulty/difficulties in the course of implementation of these Regulations in consultation with the Government of India /Ministry of Human Resource Development.
